Calendar Proposal

- Reduce the spring track out session to March 31 - April 13 (6 days)
- Move the last day of school from June 29 to June 21 (6 days)
- Provides a two week summer break between school years for Track 1 families



### Calendar Updates

Semester Two
Multitrack Year
Round

- Elementary Virtual Academy Spring
   Semester registration moved to Dec 3 9
- Reviewing Virtual Academy data to assess impact for Multi-track YR school capacities
- Collaborating with school principals to make final determinations based on individual school needs and conditions



### 2 Cohort Rotation vs. 3 Cohort Rotation

Cohort Rotations

Can social distancing requirements be maintained as currently outlined by the State of North Carolina?

- A 2-cohort rotation is not feasible for 84% of middle and high schools
- A 2-cohort rotation might be feasible in grades 4/5 at approximately 76% of elementary schools, with 24% indicating that it would not be feasible
- Consider if the state eliminates Plan A as an option
- Keeping siblings from the same families on the same daily and weekly schedules

Recommend continuing the 3-cohort rotation model<sub>17</sub>
