Context: SRO Incident Data Findings

SRO Incidents and Referrals

- 75 SROs at 75 schools within the district
 - 34 HS
 - 37 MS
 - 4 ES SROs support 10 different schools
- Offenses declined between 2017 and 2018, and have held steady since then
- Referrals have shifted toward less punitive consequences over the past few years
- Slight improvements in disproportionality among student subgroups



Context: Fall Survey Findings

Survey Results

- Over 54,000 respondents
- A majority of respondents (parents, students, staff, and community) reported favorable perceptions overall and see SROs as an important part of the school security plan
- Many respondents were unsure or unaware about SROs and their role in the school
- Modest differences among subgroups (e.g., grade span & racial/ethnic groups, etc.)



SRO Focus Groups

Focus Group Logistics

- December through early February: focus groups convened to explore themes to better unpack the survey findings
- 15 total sessions
 - Students
 - Teachers
 - Principals
 - Parents/Community Members
 - Local Law Enforcement Officers
 - Central Services Security Staff



SRO Focus Groups

Focus Group
Process
(continued)

- Consistent protocols and questions were used with every group for fairness and to allow analysis across stakeholder groups
- The facilitator guided the participants through a dialogue using the following format:
 - The session facilitator introduced the first question and the participants had 1-2 minutes to respond in writing
 - A group dialogue then occurred based on the comments the participants entered for the specific question (10-12 mins. per question)
 - Comments were unpacked until a deeper understanding was gained
 - The focus sessions lasted approximately one hour




SRO Focus Groups

Focus Group
Process

- Conducted online via Google Meet
 - o One facilitator, one notetaker, one tech support
 - o Multiple reminders to participants ahead of time
- Sampling strategy for participants strikes a balance between wide representation of voices and ensuring that stakeholders who are most invested were given opportunity
- Survey results summary shared with participants as context for the conversation








SRO Focus Group Results

Among respondents, a theme that emerged from the comments shared....


The role of SROs is not clearly defined, communicated, and understood by all stakeholders.

SRO Focus Group Results

Among respondents, a theme that emerged from the comments shared....

The frequency of positive, non-disciplinary interactions and intentional relationship-building are key determinants of how SROs are perceived.



Other Similarities Looking Across Data Collections





Equity as a Theme

- <u>SRO Incident Data:</u> From 2016-17 through 2018-19 there has been a decrease in referrals, particularly for Black and Hispanic students. Yet there is still disproportionality.
- <u>Surveys</u>: Responses were very positive overall. There are subgroups of stakeholders, especially among students, who were less positive.
- <u>Focus Groups</u>: Some felt that the disproportionate impact speaks to the need for changes; others felt that there is no role for police in schools.



The Selection of an Officer in a SRO Role as a Theme

- Number of SROs in WCPSS: 75 SROs at 75 schools within the district (34 HS SROs support 28 schools; 37 MS SROs; 4 ES SROs support 10 schools)
- <u>Surveys</u>: Schools should have more say in who is assigned;
 Respondents reflect interest in more training for SROs
- Focus Groups: Some SROs see themselves as police first; might need more counselors, etc., for those non-law enforcement functions instead



Summary Across Data Sources

- Incidents and number of referrals are trending in the right direction overall. Disproportionality, however, remains a concern.
- The majority of stakeholders have positive perceptions of SROs. Areas suggested for focus are to reduce ambiguity and even some pockets of negative perceptions, particularly among certain subgroups of stakeholders.
- Focus groups suggest that a lack of communication and definition of the SRO role, along with a lack of intentionality around positive relationship building may be a missed opportunity and could be driving some of the negative and ambiguous responses in the survey data.
